

SUBJECT: Order Amending Polling Places, Early Voting Dates, Times and Places, and Appointing additional Election Officials for the May 15, 2004 General Election.

RECOMMENDATIONS

The Board should approve the order amending polling places and other matters concerning the May 15, 2004 General Election.

BACKGROUND INFORMATION

The Board has previously ordered a General Election for May 15, 2004 and has approved polling places, officials and agreements for conducting the election. Since adoption of those orders, certain changes have occurred in the availability of polling locations and participation by entities and persons which necessitate today's amended Order.

ADMINISTRATIVE CONSIDERATIONS

Under state law the Board designates the polling places, officials and other particulars concerning the election.

By adopting the Order, the Board will: (Section 1) establish new polling places for certain precincts on election day where old polling locations have become unavailable; (Section 2) establish changes to dates, times and places for early voting; (Section 3) designate certain election officials to conduct various aspects of the election. This action is in the public interest.

**ORDER AMENDING EARLY VOTING, ELECTION DAY POLLING PLACE AND
APPOINTING ELECTION OFFICIALS FOR THE MAY 15, 2004, GENERAL
ELECTION**

WHEREAS, the Board of Trustees (the "Board") of the Austin Independent School District (the "District") has called a general election for certain trustees for May 15, 2004 (the "Election"); and,

WHEREAS, the Board has previously established the polling places to be utilized on election day for each of the election precincts, but the polling place for Travis County Precinct Numbers 357 has since become unavailable and must be changed; and

WHEREAS, the Board desires to not utilize the first Saturday and Sunday of the early voting period for in person early voting in the Election; and,

WHEREAS, the Board is required to designate certain officials to conduct various aspects of the Election and those designees have only recently been provided to the District by the County Clerk who will be conducting the election for the District.

IT IS, THEREFORE, ORDERED BY THE BOARD OF TRUSTEES OF THE AUSTIN INDEPENDENT SCHOOL DISTRICT THAT:

Section 1. Election Day Polling Place Changes. Travis County Election polling location for precinct number 357 is hereby designated as combined with precinct 366 at Mills Elementary School located at 6200 Davis Lane, Austin.

Section 2. Early Voting Changes. The board will not utilize the first Saturday and Sunday of the early voting period as day of in person early voting for the Election.

Section 3. Designation of Election Officials.

Election Day Presiding Judges and Alternate Judges

The Board hereby authorizes the appointment of the Presiding Judges and Alternate Judges for the election voting precincts in accordance with the Texas Election Code. These judges are eligible to serve in this capacity, shall perform the duties set forth for such in the Election Code, and the Board specifically authorizes these appointments. These appointments are reflected in Exhibit "A" to this Order which is incorporated herein by reference for all purposes

Section 4. Authorization to Execute. The President of the Board is authorized to execute and the Secretary of the Board is authorized to attest this Order on behalf of the Board; and the President of the Board is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 5. **Effective Date.** This Order is effective immediately upon its passage and approval.
